## Privacy Policy

We recommend that you read this section, as it contains relevant information with respect to the collection and treatment (where applicable) of your data, for example, when sending a contact form, registering or purchasing a product.

This information will be gathered by Pikolinos Intercontinental, S.A. and Pikolinos, S.L. (hereinafter, jointly "Pikolinos"), both with registered office in Elche (Alicante), calle Galileo Galilei 2, which will incorporate it into the files they own for automated and non-automated processing, duly entered in the General Data Protection Register as specified below:

- a) The data you provide us with by filling in any form on the Website or through any means of contact published there will be used by us to deal with your queries and to be able to contact you. Depending on the type of form you fill in, we will use the data for the specific purpose of the form (for example, if you complete the CV form, we will use the data to include you in the personnel selection process).
